

A SAFE WORKING ENVIRONMENT

Together we create a safe working environment



At MT Højgaard Danmark our working environment is certified

Health and safety is therefore high on the agenda, and we insist that everybody working on our construction sites respect and observe the health and safety regulations applying to the site. This is also a prerequisite for being our business partner. Everyone must take an active part in our health and safety efforts and help to make the construction site a safe place to work.

If you are unsure whether or not you are in compliance with the demands and rules, you should contact your foreman before you start working.

Helmet and safety footwear

On our construction sites, everyone must wear a helmet and safety footwear, just as everyone must, as a minimum, wear a high-visibility vest when working and driving in outdoor work areas.

Alcohol/intoxicant ban

Employees may not be under the influence of alcohol when coming into work or consume alcohol or other forms of intoxicants on MT Højgaard Danmark's construction sites

Certificates

Equipment for which a certificate is mandatory, may only be operated by persons holding the relevant and valid certificate.

Safety equipment

You must always use the safety equipment provided, even if you have received no specific requests to do so. If you are in doubt as to when or how to use the safety equipment, you must ask your supervisor before you begin the task. If you need any

safety equipment for a task, you must inform your supervisor immediately.

Dangerous substances and materials

If you work with dangerous substances or materials, you are required to know about their use. Always read the directions for use

Reversing alarms

Trucks weighing more than 3,500 kilos must be fitted with a reversing alarm when used on MT Højgaard Danmark's construction sites. Drivers at MT Højgaard construction sites must speak either Danish, English, or German.

Inspection

As a contractor, it is your responsibility to ensure that equipment is inspected in compliance with applicable legislation.

Cordons

Only plastic chains, reflective garlands or barrier boards can be used for cordoning off areas on our construction sites.

Orderliness on site

Everyone working on site must keep the site cleared. Waste must be removed from the work space on a regular basis.

Safety representative

If an employer has five employees or more on a construction site, a safety representative must be elected. The representative must take an active part in the safety work; on site and in his or her relevant safety group.

Instructions

You must receive instructions on how to perform your work. You have a duty to inform your supervisor if you do not understand the instructions.

Contractors must ensure compliance with this rule. It is their duty to give instructions and supervise their team of workers.

Duty of notification

You must notify the health and safety coordinator on site immediately if you see anything on the site which could lead to an accident.

Health and Safety Plan

You must familiarise yourself with the Health and Safety Plan and the emergency plan for the site.

Non-compliance

Failure to comply with the safety regulations on MT Højgaard Danmark's construction sites may result in summary dismissal.

IN CASE OF ACCIDENTS

- · Stop the accident
- If necessary, call an ambulance or another form of help.
- Provide the requisite first aid or life-saving measures when necessary.
- Ensure that someone is there to meet the help that has been called. Agree on a place to meet and guide the help when it arrives.
- Ensure a colleague accompanies the injured person if they are being taken to hospital.
- Make sure colleagues/witnesses are kept at a distance.
 Check to ensure they are OK.
- Contact the construction site's working environment coordinator
